The police have the power to remove a child to a place of safety in an emergency. Their power to remove the child is set out in section 46 of the Children Act 1989. The powers can be used in emergencies, where a child might suffer significant harm if they were not removed. For example, this power might be used if police are called to a home and discover that a young child has been left there alone. They may also use this power to keep a child in a specific place. For example, in hospital.

Social workers may ask the police to use police protection if they are worried that a child is in immediate danger, but they do not have time to apply to the court for an emergency protection order. Such a request should only be made if there is no other option.

- 2, concerns around doctors that have been involved with E. An investigation has been open within st Mary's hospital. I am waiting for a reply of the outcome all evidence of harm was emailed to Pals with a written statement from myself.
- 3, Isle of Wight police refusing to take a statement with evidence social services have lied throughout court documents removed my granddaughter unlawfully and should have been placed back with me where her other 2 siblings reside with me . evidence off E being drugged physically harmed. Sexual abuse can not be ruled out. DS Alexandra Dale at Isle of Wight police station. We have video evidence of this.
- 4, police cancelling a ambulance at my contact with my granddaughter (video footage)
- 5, we had to go out of our police force to metropolitan police who had grave concerns when taking evidence that ended with a crime number being created for neglect and child abuse. I will attach.
- 6, three crime numbers have now been created two of which was created in Portsmouth police station and one from metropolitan police. DS Robertson from Isle of Wight police shut down both crime numbers from Portsmouth.
- 7, allegations of child abuse made on the 20/1/24 with drugging and then again on 16/2/24 allegations of child sex abuse and needle marks. Outer of hours mash team and police where informed. E should have been escorted to hospital within 24 hrs for a CSA medical this never happened due process was not followed. After pushing for a medical 3 days

later E was taken to hospital but only had a CP medical due process was not followed.

- 8, 100s of calls to 999 and 101 have been made with 2formal complaints from myself to 101.
- 9, E continues to be harmed needle marks that can not be accounted for. Finger bruising every week in nappy area and on face. A draconian Contract was created by social services permitting us to take photos or videos of harm being caused to E. They stopped us being able to change her nappy at contact. Contact yesterday with father 25/4/24 photos taken by social worker c showing bloating and swelling all over Es body. E did not look like this at last contact on 18/4/24 concerns that what ever they are injecting her with is having a detrimental effect on E.
- 10, on the 4/4/24 an order was made by HH Judge Ellis for myself to file a written Evidence statement with evidence attached of the harm that is being caused to E and show evidence that social services have lied throughout the court hearing beginning to end. I have 100s of irrifutable evidence which can be proven in the right court of law from start to finish there is nothing that I don't have.

If you need anymore information pls let me no



As you will see we have a little girl, eveayah in what appears to be grave danger. It is the Police' job to protect property, prevent harm, uphold the rule of law.

Who is I Property? The little girl cannot convey this so her mother Paige gave her mother Juliette the grandmother permission to act on her behalf. I am conveying the message to yourselves.

As it is imperative you act swiftly id like DI 16455 Osmond who monitors my emails and has previously warned me of communicating using this forum to work with the forces concerned to make sure that the little girl is safe and will be returned to the safety of her siblings and grandmother.

Then a full independent investigation into what has taken place and who has allowed this to happen should follow.

This message trail i know is read by a few in the police force in greater manchester as Police & Crime Commissioner Burnham doesnt like questions being asked in open forums by myself.

Other forces i get email responders from acknowledging receipt. Thankyou.

This case is one of many across the UK but its urgency is paramount. The family believe eveayah is at risk and its your job to mitigate the situation. Thanks


